## A. Exterior Window Appearance

The Board reviewed photographs of the building exterior that documented the different window and frame colors and came to an agreement regarding the plan for painting.

Wayne McCorkle made a motion to paint the building siding light brown (as it is now), the window trim dark brown (as it is now), the wooden windows with two coats of off white, not to paint the vinyl windows and to paint the window edges to match the outside window color for any owners who provide access into their units. Jim Meyer seconded and the motion carried unanimously. The unit front doors will be painted the same dark brown color as the existing using metal-specific paint.

Charles Johnson will get off white paint chip samples and select a color for Board approval.

The painting contractor will provide a bid for painting the interior of the Clubhouse. Jamie Lewis was asked to select a color from the Sherwin Williams fan chart in the closet in the Clubhouse.

The covered garage openings (plywood sheets with faux railings) will be painted with the same colors as the existing. The patio doors will be repainted with same dark brown color as the existing. The contractor will need to revise the bid based on the instructions for the window painting in the motion above. Charles will ask the contractor to have the revised bid prepared by May 8<sup>th</sup>.
